5. Objectives of the Committee

- To promote awareness about the POCSO Act 2012.
- Deal with cases of sexual offences as per the POCSO Act 2012.
- Recommend appropriate action against the respondent to the Principal, Kings Height International School Rudrapur,

6. Procedure for Approaching the Committee

1. The Committee deals with issues relating to POCSO at Kings Height International School.
2. It is applicable to all students irrespective of gender.
3. A complaint of sexual offence as mentioned in Chapters II, III & IV of the POCSO Act 2012 may be lodged by the victim or a third party.
4. A written complaint may be addressed to the Chairman of the Committee. If the complaint is made to any committee member, it may be forwarded to the Chairman.
5. The committee, upon receipt of the complaint, will carry out a preliminary inquiry and submit a report to the Principal.
6. The Principal, upon receipt of the report, will take action as per Chapter V of the POCSO Act 2012.

7. Actions to Prevent Sexual Offences Against Children

Teachers' Workshops: Gender sensitization workshops shall be conducted regularly, including awareness regarding the POCSO Act.

Students' Workshops: Children are taught the difference between good touch and bad touch and encouraged to report inappropriate behavior.

Complaint Box: A complaint box has been provisioned in the school for students to submit complaints.

Self Defence Training Programme: Karate and other self-defence activities are regularly conducted to boost confidence and safety awareness.

CCTV Cameras: The entire school premises and classrooms are under CCTV surveillance monitored by the Principal and Vice Principal.

School Counsellor: The school counsellor regularly visits classes to interact with students and educate them about the POCSO Act.

8. Instructions

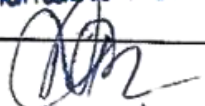

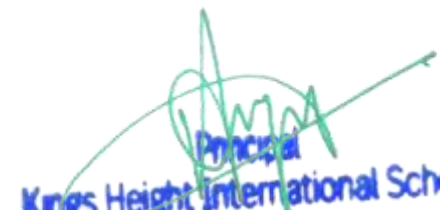
