Sub: Important Advisory for the Parents who are commuting their wards by Private Vehicles (Auto Rikshaws, Tempos, Tricycle Rikshaws, Vans, Travellers and mini buses)

Greetings from Little Flower Convent School, Sangrur!

Dear Parents,

This is to bring to your notice that, the school is in receipt of many complaints and notices from the District Child Protection Officer, and Transport Authority that the above cited class of vehicles are commuting students to and from the school which is not as per the Safe School Vahan Policy. As per the complaints, these vehicles are lacking necessary documents.

Further, these vehicles are overcrowded and have no safety measures for the safe commuting of the students. In the complaint it is also alleged that the drivers consume drugs/tobacco when plying with students.

The authorities have issued letter to the school pertaining to the above matter and have asked to sensitize the parents about the matter and curb the use of such vehicles for their wards' transport.

As per the instruction in the School Diary regarding Transport, it is clearly advised that the Parents are free to hire any vehicle for the transportation of their wards, provided these vehicles have all the documents such as, registration certificate, insurance, pollution, permit, driving Licence, fitness certificate etc. and a copy of all these submitted in the school office and prior permission must be granted from the Principal.

Therefore, the management of the school strictly advise the parents to commute their wards' to and from the school, either by themselves or by the safest means of transport with valid documents.

The parents who are sending their wards by the above cited mode of transport are required to submit the following documents of the vehicle the driver and conductor before 31st March 2024 positively.

1. Copy of the Driving Licence
2. Copy of the vehicle Insurance
3. Copy of the Registration Certificate
4. Copy of the pollution Certificate
5. Copy of the Route permit
6. Copy of the vehicle Fitness Certificate
7. Copy of the Road Tax paid receipt
8. Copy of Driver's and Conductor's Medical Certificate from Government Doctor
9. Copy of Driver's and Conductor's Police Clearence Certificate
10. List of Students travelling by the Particular Vehicle with Parent's Signature.

The authorities have warned the school that if these vehicles continue to ply with students from 1st April 2024, they will attract serious legal penalties to the extreme of the vehicles may be impounded by the authorities on the way.

Therefore, it is requested that, enquire and verify the validity of the certificates and condition of the vehicle and driver also submit the documents as mentioned above.

Hope all of you will take this in letter and spirit and act accordingly.

Let us all join hands to commute our wards safely to and from school.
