Dear Parents,

The Government of Uttarakhand has allowed pupils back in school in staggered manner from August 2, 2021, many other states are waiting until some more time to resume schools. Attendance remains voluntary since the state sops specify that parents can decide what their wards should do. Reopening will prevent a complete washout year for students but we must understand that pandemic is not past yet.

LPS plans to start the school for **class 9<sup>th</sup> and 10<sup>th</sup> beginning Monday, August 9, 2021,** with restricted school time and no or minimum group activities.

Please note the following:

- 1] The school will operate from 9am to 1pm.
- 2] The offline school will run for 5 days in a week from Monday to Friday and on Saturday we continue with online teaching.
- 3] In the event of extreme weather condition, the school will operate in online mode, please look for the notice on the app before sending your ward to school.
- 4] You are expected to send your ward to school not before 8.45am as the school gates will open only after the specified time.
- 5] Children will be allowed in school, with mask and own bottle of sanitizer.
- 6] Please read the consent letter carefully and give your consent through reverting SMS on the app, without which your ward will not be entertained for physical school.

Subject: Adherence to guidelines of COVID 19 as per SOP of the Govt. / Board / School by my son.

I have carefully read all the guidelines issued by the school and I hereby state that my ward will adhere and strictly follow the precautionary measures and guidelines as prescribed by Govt/ Board and school during his attendance to off line classes.

I would like to send my son studying in LONGVIEW PUBLIC SCHOOL, Nainital in the Year 2021, from the re-opening day of the school. I understand and agree to follow and instruct my ward to follow all safety measures for protection from Covid-19 pandemic and also to abide by the rules and regulations issued from the school for safety and health of my ward and fellow students at the school.

3. **My ward will wear face mask, carry Sanitizer, his own water bottle, eatables and maintain social distancing. He will not share his water and lunch with others.**

4. My ward will immediately bring to your notice any symptoms such as cold, cough, fever, headache etc., he may experience during the course of offline class and I will ensure my ward will not attend offline classes if he is experiencing any symptoms relating COVID 19.

5. I hereby, give my consent to send my son to the school. My son is well aware of the precautionary measures and will not be instrumental in spreading the COVID 19 to any of the co-students/teachers.

6. I also give my consent to **Longview Public School** for taking Student's temperature and observing Student for Symptoms and if any Symptoms are present, I shall arrange for immediate pickup of my ward from the premises of **Longview Public School** and allow school to report the matter if required to the local COVID-19 authority.

7. By agreeing to this consent, I acknowledge the contagious nature of COVID-19 and voluntarily assume sole responsibility and will not hold **Longview Public School** and its employees and representatives liable and make no claims from them.
