Subject: Guidelines for CBSE Examinations at Dr. Rajendra Prasad Kendriya Vidyalaya (Exam Centre)

Sir/Madam,

As our Vidyalaya has been designated as the CBSE Examination Centre for the students of your school, I am writing to share the following guidelines to ensure the smooth conduct of the upcoming exams:

Location & Entry: Our school is situated within the Presidential Estate. Students and staff must enter through Gate No. 30, located on Mother Teresa Crescent Road (directly opposite Talkatora Stadium).

Transit: The Vidyalaya is within walking distance of Gate No. 30.

Identification: All students and accompanying teachers must carry their School Identity Cards in addition to their CBSE Admit Cards.

Parental Access: Parents are not permitted to enter the estate. In exceptional circumstances, details of the parent and their vehicle must be submitted to us in advance for clearance.

Punctuality: Please ensure students arrive well in advance. As per CBSE norms, no entry will be permitted after 10:00 AM.

Staff Requirements: One teacher from your institution is required to be present for the opening of question papers and to assist with invigilation duties thereafter.

CWSN Documentation: Kindly provide all necessary documentation for Children with Special Needs (CWSN) regarding eligibility for extra time, scribes, or other mandated facilities.

Student Briefing: Please ensure all candidates are thoroughly acquainted with the official CBSE candidate guidelines.
