3. Counter foil of the Application Form.
4. **Three** digital passport size photographs with child's name and the date of clicking inserted in the photograph.
5. **Caste certificate** (If any). Kindly bring the original copy.
6. **Transfer Certificate from the previous school for Class 1st to Class 9th** (If it is a School affiliated to any Board other than ICSE it should be countersigned by the Educational authority concerned like Education Officer, Inspector of the School etc.)
7. All T.C.'s from outside U.P. for the **Class 1st to Class 9th even from ICSE Affiliated Schools** needs to be countersigned.

P.S. - One of the Parents should be present to fill up the Admission Form. Legal Guardians should have the letter of authority from the natural parents of the child.

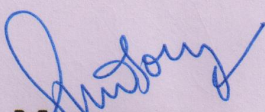

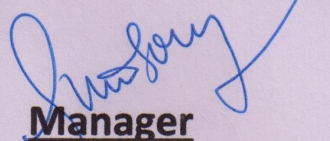
