EXPLANATORY NOTES ON TABULATION REGISTER

ICSE YEAR 2025 IMPROVEMENT EXAMINATION

- A. The Tabulation Register contains the results of the school candidates. This sheet is for the school record.
- B. Since the Tabulated Results constitute CISCE's permanent record of the examination, any apparent error should be reported to CISCE, through the Principal, immediately after the results are received.

EXPLANATORY NOTES:

- 1. Name of the School is given in the top row along with **Centre Number.**
- The **Unique ID** is printed under the Unique ID column, and name of the candidate is printed under the specific column
- 3. The column **D.O.B** refers to the Date of Birth of the candidate, which is shown for example as 30/09/1988.
- 4. The column **GENDER** indicates: BOY/GIRL
- 5. The column **T.O.E**: Type of Entry:

Type 1 & 3: Entry for the award of Pass Certificate Cum Statement of Marks

Type 2 & 4: Entry for a Supplementary Examination

6. The column NTY: Nationality

I is for: Indian

F is for: Foreign

7. The column **SCD**:

Type 0: is for O.B.C.

Type 1: is for Scheduled Caste (SC)

Type 2: is for Scheduled Tribe (ST)

Type 3: is for candidates who belong to General Category

- 8. **SRL. No.**: indicates the computerised serial number allotted to candidates who have been awarded a Pass Certificate Cum Statement of Marks.
- 9. The Index Number, mother's name, father's name / guardian's name is / are printed in the second row.
- 10. Result

QLF: indicates Qualified in Examination

NOLF: indicates Not Qualified in Examination

11. The word Qualified means that the candidate has fulfilled the requirements for the award of a Pass Certificate Cum Statement of Marks.

Note: Pass Certificates Cum Statement of Marks are awarded to candidates who obtain Grade 7 or less in atleast 5 subjects with English as one of the subjects, and at least Grade D in Socially Useful Productive Work (SUPW).

- 12. **A Supplementary Statement of Marks** is issued to a candidate who has been awarded a <u>Pass Certificate</u> in an earlier Examination and who has re-entered for one or more subjects, to improve his/her subject grade/s, in accordance with the Regulations.
- 13. **Subjects Grades and Marks**: Abbreviations of subject names are given below. On the tabulated results, against each Subject, the first number refers to the Grade and the second indicates the percentage marks obtained by the candidate followed by the breakup of marks given in brackets () for each paper in that subject.
 - The tabulated results show the performance of the candidates as a whole and indicate the standard reached in each subject taken by grades 1-9, 1 being the highest and 9 the lowest. Very good is indicated by grades 1 and 2. Grades 3, 4 and 5 indicate a pass with credit, 6 and 7 indicate a pass and 8 and above a failure. The pass mark in each subject is 33%.
- 14. **SUPW** refers to the subject: Socially Useful Productive Work and Community Service. The letter grade against it indicates the grade obtained by the candidate in SUPW. The standard of Socially Useful Productive Work and Community Service(internally assessed) is shown by grade A, B, C, D or E, A being the highest and E the lowest. A, B, C or D indicate a pass and E a failure.
